### ATTENDANCE REQUIREMENTS

#### (A) Punctuality

All participants of the course are required to fulfill full strict attendance record for the issuance of certificate. Participants should arrive 15 minutes before the course official starting time for registration.

0.5 IA CPD hour will be deducted for any late arrival or early departure for over 15 minutes. MPFA and SFC credits will only be given to participants who attend more than 80% of the course.

No admission will be allowed if anyone arrives 30 minutes after the course official starting time and, in addition, anyone leaves more than 30 minutes earlier, no certificate will be issued.
